RESOLUTION No. 2013-01

APPROVING THE DETERMINATION OF AUTOMATICALLY FISCALLY ELIGIBLE MUNICIPALITIES

WHEREAS, the Financial Restructuring Board for Local Governments ("the Board"), created pursuant to Chapter 67 of the Laws of 2013, is empowered by §160.05 of the Local Finance Law to, among other things, deem certain municipalities as Fiscally Eligible Municipalities; and

WHEREAS, municipalities with an average full value property tax rate greater than the average full value property tax rate of seventy-five percent of counties, cities, towns, and villages with local fiscal years ending in the same calendar year as of the most recently available information, or municipalities with an average fund balance percentage below five percent, must be deemed a Fiscally Eligible Municipality; and

WHEREAS, municipalities that have not reported the necessary information to the Office of the State Comptroller cannot be deemed a Fiscally Eligible Municipality; and

WHEREAS, the Office of the State Comptroller has supplied the data to make this eligibility determination;

NOW THEREFORE BE IT RESOLVED that the Board approves the list of automatically Fiscally Eligible Municipalities attached hereto.

This resolution shall take effect immediately and remain in effect until modified, replaced, or repealed by resolution of the Board.
